## **PART 1 - PRELIMINARY**

### **Citation**

1. This local law may be cited as *Brisbane City Council Local Law (The Gabba Traffic Area) 2000*.

### **Objects**

2. The object of this local law is to provide for Council's regulation of parking by time in a particular part of the City (a "traffic area").

### **Definitions**

3. (1) In this local law:-

“**City**” means the area comprised in the City of Brisbane under the City of Brisbane Act 1924;

“**Council**” means the Brisbane City Council;

“**official traffic sign**” has the meaning given to it in the *Transport Operations (Road Use Management) Act 1995*;

“**park**” has the meaning given to it in the *Transport Operations (Road Use Management) Act 1995*;

“**traffic area**” has the meaning given to it in the *Transport Operations (Road Use Management) Act 1995*.

## **PART 2—AMENDMENT OF PARKING AND CONTROL OF TRAFFIC LOCAL LAW**

### **Local law Amended**

4. This Part amends the Parking and Control of Traffic Local Law.

### **Amendment of Part 5, s.2(1)**

5. (1) Section 2(1)—

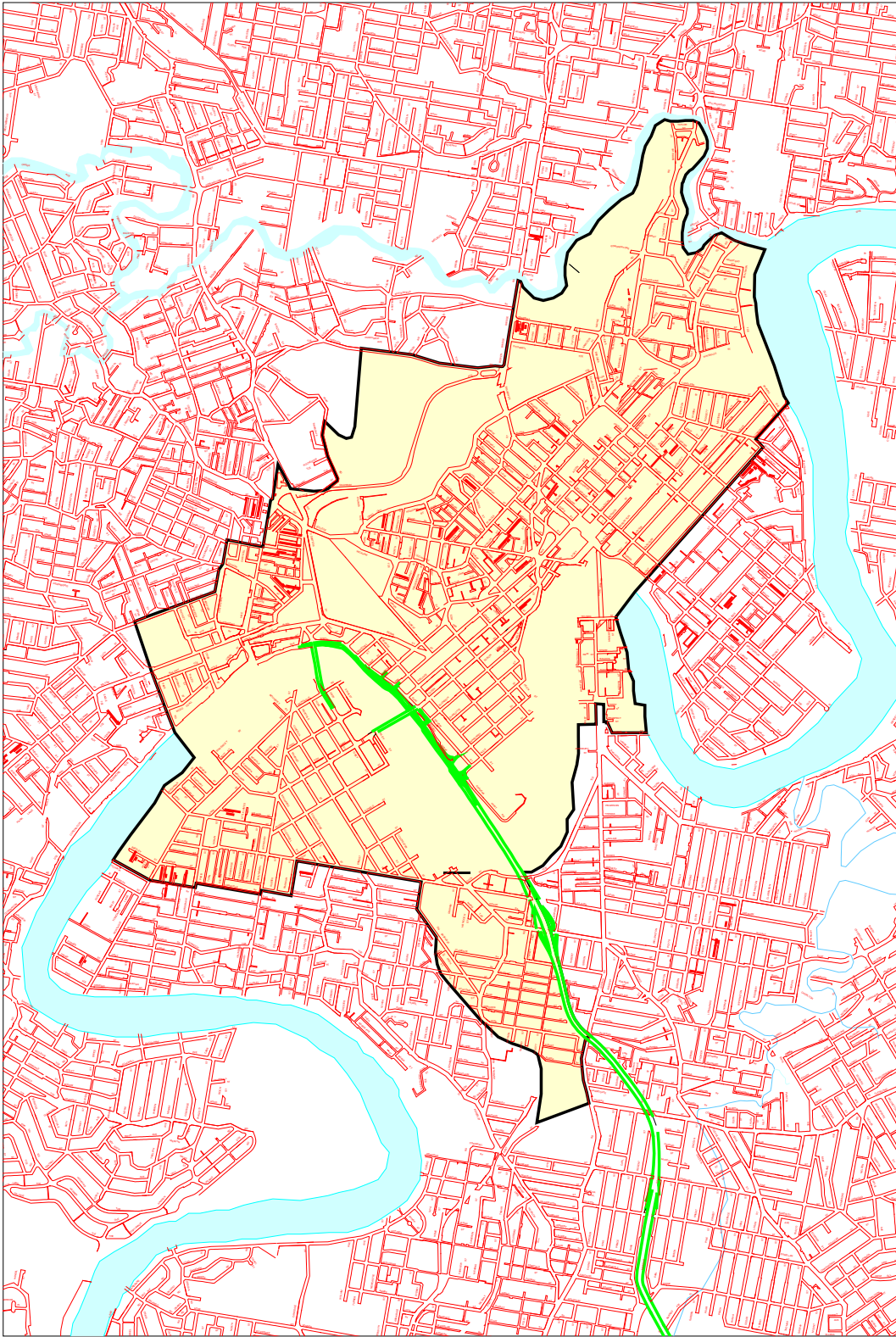

### **PART 3—THE GABBA TRAFFIC AREA**

#### **Traffic area**

7. The part of the City the boundaries of which are defined by the black bordering indicated on the map in the Schedule is declared to be a traffic area.

#### **Name of Traffic area**

8. The traffic area declared under section 7 is named The Gabba Traffic Area.

### **PART 4—REGULATION OF PARKING**

#### **Regulation of Parking**

9. Parking in The Gabba Traffic Area is allowed only for the maximum time specified on the official traffic signs mentioned in section 10 at the dates and times specified on those official traffic signs.

Infringement notice penalty – 0.75 penalty units.<sup>1</sup>

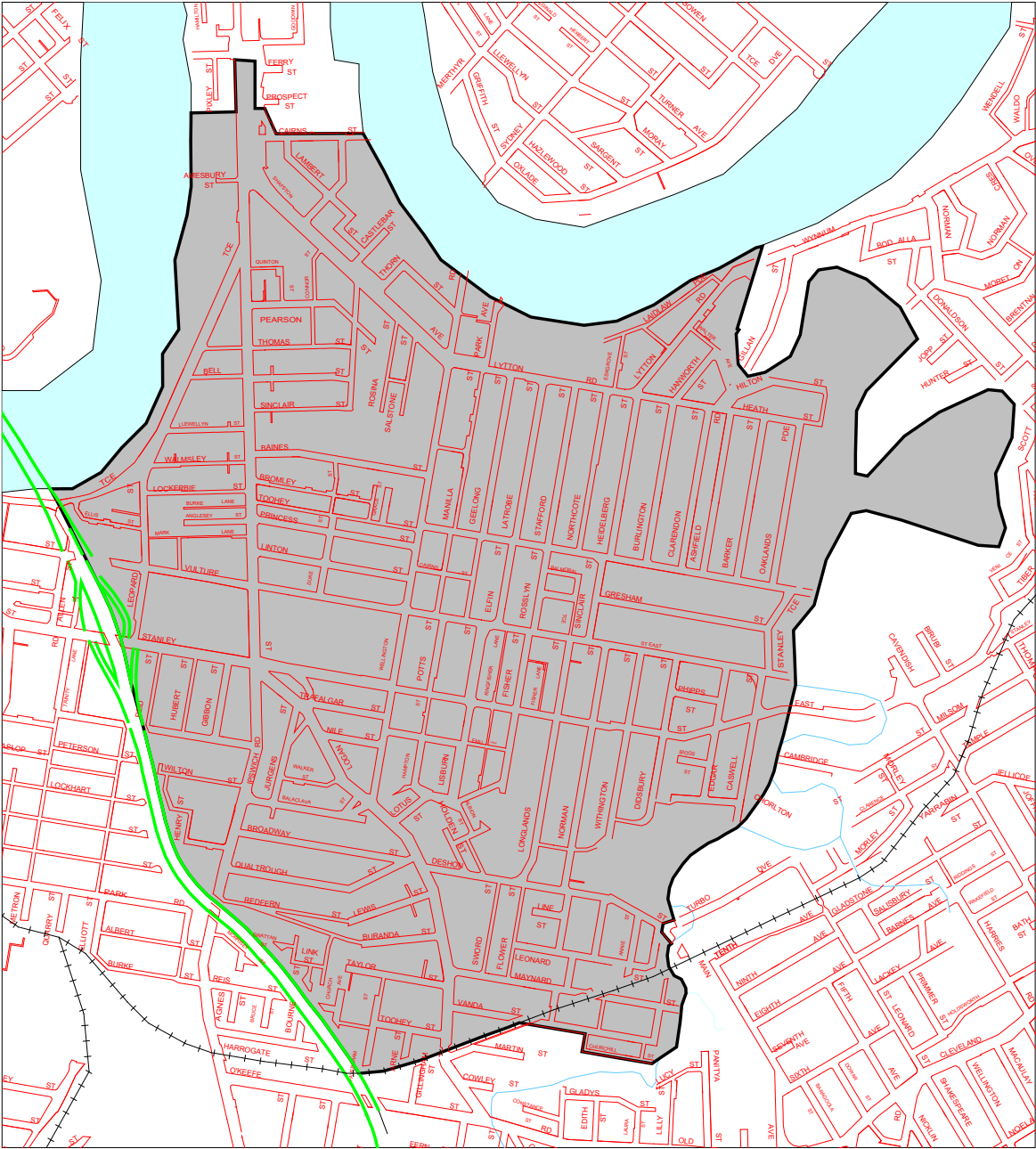
#### **Commencement of Regulation of Parking**

10. The regulation of parking under section 9 commences on the day after official traffic signs indicating how parking is regulated under section 9 are installed by Council on the road at every road entry to The Gabba Traffic Area.
